**ORDINANCE NO. 22A**

ORDINANCE SETTING COMPENSATION OF TOWNSHIP SUPERVISORS.

**ENACTED, by the Township of Haines under authority of the Second Class Township Code and other applicable law, as follows:**

**Section 1.     Compensation.**

Each Supervisor of Haines Township shall receive compensation as a Supervisor in the annual amount of \$1,875.00. Said compensation shall be paid in equal monthly installments. Said compensation shall begin for each Supervisor at the beginning of the Supervisor's next term occurring after the date of enactment of this Ordinance. Each Supervisor shall continue to receive annual compensation in the amount of \$1,500.00 until the increase in compensation set forth in this Ordinance takes effect.

**Section 2.     Meeting Attendance.**

No compensation shall be paid to a Supervisor in any month in which the Supervisor has failed to attend at least one meeting of the Board of Supervisors during that month.

**Section 3.     Severability.**

The provisions of this Enactment are severable and if any of its provisions are ruled by a court invalid or unconstitutional, such decision shall not affect or impair any of the remaining provisions of this Enactment. It is declared to be the intention of the Governing Body that this Enactment would have been adopted if such invalid or unconstitutional provision had not been included.

**Section 4.     Repeal.**

Any ordinance inconsistent herewith is hereby repealed by the enactment of this Ordinance.

**Section 5. Adoption.**

This Enactment is adopted and enacted the 20<sup>th</sup> day of December, 2012.
