

ORDINANCE NO. 2023-1

AN ORDINANCE OF THE HAINES TOWNSHIP SUPERVISORS, CENTRE COUNTY, PENNSYLVANIA, DESIGNATING CERTAIN TOWNSHIP ROADS AS SNOWMOBILE AND ATV ROADS, DESIGNATING THESE ROADS AS ROADS SHARED BY SNOWMOBILES AND ATVS WITH VEHICULAR TRAFFIC, AND PROVIDING FOR THE POSTING OF ADEQUATE NOTICES.

The Board of Supervisors (“Board”) of Haines Township, Centre County, Pennsylvania (“Township”), hereby enacts, adopts, and ordains the following:

Section 1: Purpose. The purpose of this Ordinance is to establish certain roads located in the Township as snowmobile and ATV roads so as to allow for the sharing of these designated roads by snowmobiles and ATVs with vehicular traffic.

Section 2: Definitions. The definitions of “ATV,” all-terrain vehicle,” and “snowmobile” shall be defined in the Motor Vehicle Code of the Commonwealth of Pennsylvania.

Section 3: Designation. The Board hereby designates the following Township roads as ATV and snowmobile roads so as to permit said roads to be shared by snowmobiles and ATVs with vehicular traffic:

Section 4: Posting Signs and Notices. Adequate signs and notices of such designation and determination shall be sufficiently and prominently displayed as required by 17 Pa. Code § 51.83.

Section 5: Liability. In accordance with the Motor Vehicle Code of the Commonwealth of Pennsylvania, specifically 75 Pa. C.S. § 7722, the Township hereby assumes no liability whatsoever as a result of designating any of the aforesaid roads as snowmobile roads and ATV roads.

Section 6: Repeal. All ordinances or resolutions or part of ordinances or resolution, insofar as they are inconsistent herewith, are hereby repealed.

Section 7: Severability. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of the Township, that this Ordinance would have been adopted had such constitution, illegal, or invalid sentence, clause, section, or part thereof not been included therein.

Section 8. Effective Date. This Ordinance shall become effective five (5) days after its enactment.
