HAINES TOWNSHIP BOARD OF SUPERVISORS MARCH 21, 2024

On March 21, 2024, at approximately 6:30 p.m., Chairman Daryl Schafer called the regular monthly meeting of the Haines Township Board of Supervisors to order. The meeting was held in the Haines Township Building located at 337 E. Aaron Square in Aaronsburg, PA. The call to order was followed by the pledge of allegiance and a moment of silence. PUBLIC COMMENTS: Andrea Vonada, Tax Collector gave an update on the new real estate tax bill vendor that was selected solely by the Centre County Tax Office. There were no issues or findings, all expenditures were approved, and all revenues were assigned properly. The audit was conducted per auditing standards generally accepted in the United States of America (GAAS). The DCED report was in compliance with statutory reporting requirements. Ms. Zoerner complimented the Secretary-Treasurer for her job performance and ability to resolve accounting issues independently.

Mark Hosterman reported that College Township agreed to a purchase price of \$28,000 for the 2014 dump truck and they will let us know when it is ready for pick up. Mr. Hosterman also mentioned that roughly \$236.00 was spent to get several pieces of equipment ready to send to Fraley's auction on March 23rd. There will be an additional cost for AM Logging to transport several of those items. The items being sent to the auction are a roller, belt loader and 94 dump truck.

Penns Valley Emergency Medical Services, Inc. – Bari Deaven reported that things are going well with a stable staff. Ms. Deaven also reported that because of a good return on their investments they can give the staff raises.

CORRESPONDENCE:

The Board of Supervisors received and reviewed an email regarding a proposed one-day detour on SR 2018 for a pipe replacement. The Board unanimously agreed to there was no objection to this proposal.

OLD BUSINESS:

Daryl Schafer moved to adopt the Haines Township Nuisance Ordinance 2024-1 amending and superseding Chapter 83A of the Code of the Township. Randy Ream seconded the motion and the motion carried.
