

**HAINES TOWNSHIP  
BOARD OF SUPERVISORS  
JUNE 18, 2024**

On June 18, 2024, at approximately 6:30 p.m., Chairman Daryl Schafer called the regular monthly meeting of the Haines Township Board of Supervisors to order. The meeting was held in the Haines Township Building located at 337 E. Aaron Square in Aaronsburg, PA. The call to order was followed by the pledge of allegiance and a moment of silence. In attendance: Chairman Daryl Schafer, Vice-Chairman Delmer Homan, Supervisor Randy Ream (via Phone), Secretary-Treasurer Kimberly Claar, Roadmaster Mark Hosterman, Tax Collector Andrea Vonada, Residents Corby Stover, Melissa Stover, Curtis Stover, and Melody Breon.

**PUBLIC COMMENTS:** Curtis Stover inquired who is responsible for enforcing Zoning Ordinances/Permits. Curtis Stover also asked who has been issued permits and requested that the Board amend several zoning ordinances. Curtis Stover expressed his frustration with the requirement from the Building Code to have 2 sets of stamped engineered drawings for a 9x11 roof over the church entrance. Curtis Stover requested the building code agency Bureau Veritas be fired and the Township look for a different building code agency.

Corby and Melissa Stover expressed frustration with having to stop renovations in April and still have not been issued a Building Permit.
